- We identified curly leaf pond weed (CLPW) in our lake last year. Our AIS team is taking steps to control it. Thanks goes out to the AIS team that is doing the hands on work. Thank you to those who provided financial support for AIS work this past year.
- The proposed Sandpiper and Line 3 oil pipeline projects that could cross the Headwaters of the Mississipppi and our watershed leading to our lake have been delayed, but not stopped. Much work and fund raising has been done to fight this battle.
- COLA continues to work to protect the water quality of our lake and river. We are thankful for their work in preserving this beautiful resource.

We have a great Board of Directors, but need to find more people (like you) that will fill vacancies and provide energy, ideas & future leadership.

to provide hamburgers & hotdogs, coffee & juice and paper plates and utensils. We are asking you to bring a salad or dessert. You may also choose to bring your own beverage. We promise to keep the meeting portion short. Lots of parking is available at the park.

AIS TEAM REPORT - Don Sells: This year continues to be a concern regarding aquatic invasive species. Last year the DNR sampled over 500 sites in the littoral zone completely around the lake (refer to the map on the website) and found only three small areas of infestation. Following this vegetation sampling, the board and the AIS team have been evaluating and pursuing appropriate responses. We are consistently pulling CLPW where we see it. The decision was made to explore chemical treatment to manage the spread of this invasive. The herbicide, Endothall, is the recommended application. Although the studies have suggested that Endothall is relatively safe, any use of chemicals has to be very carefully evaluated as there may be negative consequences to other plants and wildlife. Following an AIS Team meeting with the DNR Dept. of Water and Ecological Services, it was determined that the amount of growth of curly leaf pondweed in 2015 was not significant enough to warrant treatment this year. We will continue to monitor and pull weeds as

possible. So far in 2016 no CLPW has been found at the three sites where it was visible last year. Perhaps our lake has the right vegetation and clarity to resist its spread, we hope this is the case.



The Hubbard County AIS Prevention and Management Plan is in full operation for the summer season. Hubbard County's share of the state funding is \$249,244 for the prevention and education efforts. The county has now assumed full administration for the Boat Inspection Program. Components of the plan are: public awareness, prevention, early detection, a rapid response team and mitigation and management. The most effort and dollars are in the prevention area. This includes the boat inspection program. Fish Hook Lake and River Association will receive 720 hours of paid inspections and has contributed money for 280 additional hours. Todd Township donated \$1000 to this effort. Additionally, Fish Hook will be conducting veliger (zebra mussels) sampling with the costs paid with county AIS funds. Don and Jan Rumpza have again volunteered to take

The AIS Team's other effort will be the testing of dissolved oxygen and temperature at the deepest part of the lake (75 feet). The analysis has been done for the past five years. This scientific probe provides an indicator of the health of our lake (refer to results on the FHLRA website). AIS team members: Bob Stelter, Dave Mohn, Denny Diedrich, Don Rumpza and Don Sells

As a reminder, **a watercraft decontamination unit is available**; it is located at the north side of the road as you enter the Park Rapids waste disposal facility off of Henrietta Ave. It is a <u>free service</u> to everyone.



AIS Update: The list of invasive species attacking MN lakes and rivers continues to grow. Last summer a new and very destructive aquatic invasive species was discovered around the DNR boat ramp in Lake Koronis, starry stonewort. Researchers in Michigan have labeled starry stonewort as the most destructive AIS in that state, so this infestation is serious and serious action should be taken to stop its spread to other lakes.

<u>Update on Sandpiper and Line-3 Pipelines</u>: (note: This is very complex situation. The following explanation is given to try to summarize the actions taken to date. The FHL&River Assn is attempting to provide an update, not take a legal stand on this issue.)

The application for the Sandpiper pipeline was filed by Enbridge with the Public Utilities Commission in Nov. 2013. Public meetings were held, there were evidentiary hearings before an Administrative Law Judge and an Administrative Law Judge report recommending a negative response to the PUC: However, the PUC still approved the Certificate of Need with limitations on the routes to be considered.

The PUC did not require Enbridge to conduct the required Environmental Impact Analysis. This resulted in a protest and the Court of Appeals ruling in Sept 2014 stating the law requires an Environmental Impact Statement before any decision can be made on a Certificate of Need. The COA set aside prior decisions of the Public Utilities Commission granting the Certificate of Need and the proposed routes to be followed.

The Court of Appeals ruling means the entire PUC process starts all over again. An Environmental Impact Assessment must be conducted. The current fight is over how detailed the new Environmental Impact Analysis must be. Enbridge wants to minimize the scope of the study and eliminate the study of alternatives. The new timetable seeks to complete a new Environmental Impact Study by the spring of 2017.

POSSIBLE IMPACT ON FISHHOOK - The proposed route would cross Hay Creek which feeds Island, Eagle, Potato and Fishhook lakes. A pipeline spill could damage the lakes and could limit lake use resulting in reduced property

values. The pipeline would also cross the Mississippi twice and would go through wetlands areas. Enbridge's preferred pipeline route goes through the area of highest susceptibility for ground water contamination in Hubbard County which creates a threat for our aquifer that provides municipal water and irrigation water. The stated benefits from the pipeline include some rents paid to landowners and some new jobs during the construction period. (note: some jobs would not be filled by local residents).
